Online Student-Directed Assessments

- 1-2-3 Test, Career Aptitude Test: This free career aptitude test can provide insight into a person's job personality.
 Based on a characterization of the individual's personality in terms of Holland Code personality types, he/she will learn what kind of work environments and occupations would be best. The results of this career test provide individuals with a list of professions and occupations that fit their career personality.
