# Looking Forward to Employment for Youth with Disabilities in 2018

The National Collaborative on Workforce & Disability for Youth (NCWD/Youth) developed the Guideposts for Success, which outlines principles that will help to shape public policy and, when implemented, result in better education, employment and independent living outcomes. These principles state that all youth need the following:

- School-based preparatory experiences (to perform optimally in all educational settings)
- Career preparation and work-based learning experiences (to make informed choices about careers)
- Youth development and leadership (to be self-directive in life choices)
- Connecting activities (to access post-school options)
- Family involvement and supports (to promote social, emotional physical, academic and occupational growth which result in better post-school options)

All of these guideposts focus on preparing students for the future and employment is central to students' futures. Postsecondary education and training prepare students for careers and employment. Independent living often hinges on the ability to become employed and provide support for oneself. Employment is a



prominent aspect of life. Unfortunately, we have seen that employment statistics for students with disabilities lag behind employment statistics for students without disabilities. NCWD/Youth reports, "Young adults with disabilities are three times likelier to live in poverty as adults than their peers without disabilities" (Guideposts for Success, 2012, p. 2). Understanding that independent living and the ability to live a self-directed, meaningful life are often dependent on employment enables us to see the significance of lagging employment outcomes for students and people with disabilities. Fortunately, the issue of employment for students with disabilities is gaining a significant amount of attention through federal, state and local resources. This Topical Brief will examine some of these employment resources.

# Learning from Labor Force Statistics for Individuals with Disabilities

In 2017, the Bureau of Labor Statistics reported the 2016 labor force characteristics for persons with and without disabilities. The rate of employment for persons with disabilities increased to 17.9%



in 2016 from 17.5% in 2015. This represents a .4% increase. While this may seem minor, in reviewing the three years from 2013 to 2016, the improvement was only .3%. During the same period of 2013 to 2016, the employment rate for persons without disabilities improved by 1.3%. The growth in numbers of employed persons without

disabilities has significantly outpaced the growth of employed persons with disabilities over the past four years. See the charts below showing the employment trends from 2013-2016 for persons with and without disabilities.

Another striking difference in the labor force characteristics between persons with and without disabilities is the number of persons not in the labor force. For all adults, age 18 to 64, about 60% of those with disabilities were not in the labor force, compared with 20% of those without disabilities who were not in the labor force. The number of persons who are not in the labor force are not reflected in employment and unemployment statistics. The fact that the percentage of persons with disabilities who are not in the labor force is 40% higher than persons without disabilities sheds additional light on the significance of the employment gap.

Familiarity with the disparity in employment statistics between those with and without disabilities serves as a reminder of the urgency of the work being done to assist students with disabilities to prepare for the transition from school to postsecondary education, training and employment.



## **Listening for Apprenticeship Opportunities**

Apprenticeship programs have long been an effective strategy for connecting entry-level job-seekers to paid employment through on-the-job training. The Office of Disability Employment Policy (ODEP) reported that apprenticeships "should be considered as a possible option for promoting successful long-term employment outcomes for people with disabilities at competitive salaries and with little or no educational debt" (2015, p. 3).

ODEP promotes apprenticeship programs not only as a means to promote the inclusion of persons with disabilities in paid on-the-job training, but also as a strategy to assist employers to recruit and train workers needed in their industries. Guides explaining apprenticeship for the various stakeholders involved in apprenticeship are available through the ODEP website as well as a toolkit that includes six modules and a comprehensive look at apprenticeship and its potential to help employers and jobseekers. Assistance with Finding a Job

Florida Department of Education, Division of Vocational Rehabilitation (VR)
VR assists people with disabilities for find

and/or keep a job in a meaningful career to the job seeker. The VR website can help guide you to find information about a VR office that is nearest you.

#### CareerSource Florida

CareerSource is the statewide workforce policy and investment board. Their primary goal is to connect businesses with skilled employees and training solutions. The CareerSource <u>website</u> can guide you to online job search tools and can connect you to a local team near you.

#### The Workforce Innovation and Opportunity Act (WIOA)

As described by the DOL Employment and Training Administration (n.d.), "WIOA is landmark legislation that is designed to strengthen and improve our nation's public workforce system and help get Americans, including youth and those with significant barriers to employment, into high-quality jobs and careers and help employers hire and retain skilled workers." WIOA includes specific directives for youth which includes the provision of preemployment transition services (Pre-ETS) for students with disabilities. Florida's Division of Vocational Rehabilitation (VR) is fulfilling its role as the agency designated to ensure Pre-ETS are provided to transition-age youth with disabilities through the Student Transition Activities Record (STAR) program. STAR provides the following Pre-ETS:

- Career Exploration Counseling
- Work Readiness Training
- Self-Advocacy and Peer Mentoring
- Postsecondary Educational Counseling
- Community-Based Work Experiences

## Technical Assistance and Research through the National Technical Assistance Center on Transition (NTACT)

NTACT's primary goal is to research evidence-based and promising practices in transition in order to disseminate the most effective strategies that support improved postsecondary outcomes for students with disabilities. One of NTACT's major contributions is the Effective Practices and Predictors Matrix. This document shares transition practices and predictors related to education, employment and independent living based levels of evidence in research literature.

Generally speaking, evidence-based practices:

- are based on sound research designs and demonstrate the strongest evidence of effectiveness
- demonstrate a moderately strong evidence of success
- are based on a wider variety of research designs and may demonstrate mixed outcomes in regard to effectiveness.

These practices provide transition service providers with information about effective strategies supported by evidence from research.

The <u>Effective Practices and Predictors Matrix</u> reports the following in regard to predictors of postsecondary employment:



#### **Abilities Work**

Florida's Employment First Initiative has developed the Florida Abilities Work Web Portal and Helpdesk to help employers find qualified candidates with disabilities who are ready and able to work in their communities and provide them with information that would help with their hiring decisions. The web portal offers employment information for both employers and job seekers.



# Agency for Persons with Disabilities (APD) Employment Enhancement Program (EEP)

The EEP is a project designed to provide supported employment services to individuals on the APD waitlist. Jobseekers participating in the EEP project may receive funding for the following types of services: Supported Employment coaching to secure a good job match; Supported Employment follow-along services to help retain a job; assistance with transportation needed for work and securing paid internships as pathways to competitive employment.

#### **Best Buddies Jobs**

Best Buddies Jobs provides supported employment to help individuals with Intellectual and Developmental Disabilities (IDDs) attain and maintain jobs of their own choosing by providing ongoing support and training. It enables people with IDDs to earn an income, pay taxes and work in an environment alongside others in the community. Best Buddies Jobs has placed more than 500 individuals in integrated employment positions.

#### **Customized Employment**

This site provides detailed information on customized employment including customized entrepreneurship and benefits planning and counseling.

#### Florida Department of Education Apprenticeship Resources

#### Florida Division of Vocational Rehabilitation (DVR)

DVR provides services for eligible persons with physical or mental impairments designed to enable them to prepare for, get, keep, or regain employment. Youth services include job-site assessment/accommodations, job placement, job coaching, on-the-job training and supported employment.

#### Job Accommodation Network (JAN)

Individualized technical assistance, consulting and mentoring services to individuals with disabilities, families and service providers including referrals, accommodations and self-employment/small business development expertise.

#### **MyCareerShines**

This online planning tool is a comprehensive career planning system. With MyCareerShines, Floridians will be able to explore careers, identify personal preferences for future employment and learn about the educational requirements for specific professions.

#### mySkills myFuture

This U.S. Department of Labor electronic tool helps workers or those looking for work identify occupations that fit their particular skill set, learn more about suggested employment matches, apply for a job, or locate a local job training program.

#### National Technical Assistance Center on Transition (NTACT) Resources

NTACT conducts research on transition practices, designs informative transition resources and provides technical assistance to support improved postsecondary outcomes for students with disabilities.


